### ADMISSIONS to M.Sc. Programmes, 2019

Candidates who have applied for admission to M.Sc. (Economics), M.Sc. (Financial Economics), M.Sc. (Agribusiness Economics) and M.Sc.(International Business Economics and Finance) are hereby informed that the process of admissions for the batch of 2019-21, and to the GIPE Hostels, shall be as specified here below.

1. Result of the Entrance Test has been declared on **June 18, 2019** and is available on our website.
2. Candidates shall be communicated offer of admission on 19-06-2019 via **e-mail**, in the order of their rank and in the order of their preference.

4. **Confirmation of admission and payment of Programme Fees**

- a. Candidates who have been offered admission via e-mail communication **shall not be required to visit the Institute in person to confirm admission**. Candidates who accept the offer and wish to confirm admission shall be required to pay the requisite Fees through online payment gateway on or before the last date for payment of Programme Fees, as per (3) above.

- b. Upon payment of Programme Fees, the candidate shall communicate via e-mail to [admission@gipe.ac.in](mailto:admission@gipe.ac.in) with a copy to [fin.accts@gipe.ac.in](mailto:fin.accts@gipe.ac.in) confirming acceptance of admission, and specifying the transaction number of the online payment via gateway.
- c. If a candidate does not accept the offer of admission and pay the requisite Programme Fees within the specified time as per schedule at (3) above, the candidate shall forfeit his/her claim on admission and the seat will be offered to the next candidate in order of rank and preference.
- d. Admission shall be treated as confirmed only upon receipt of Programme Fees.

- e. The Academic Office shall verify receipt of Programme Fees and thereafter shall communicate via e-mail to the candidate confirming **Provisional Admission**.
- f. Candidates are requested to note that all admissions shall be provisional until the required documents as mentioned in the Admissions Brochure are submitted to the Institute for the verification.

## 5. Document Verification

- a. **Reserved Category (SC/ST/OBC/VJNT/DTNT/EWS/SBC)** who have confirmed admissions shall personally report to Academic Office at the Institute on **Thursday, July 18, 2019 and Others on Friday, July 19, 2019** for submission and verification of documents. The students shall carry with them the original, as well as a set of self-attested photocopies of the following documents:
  - i. Statement of marks of graduate examination
  - ii. Valid proof of date of birth (as per government rule)
  - iii. Transfer/Migration Certificate
- b.
  - i. Statement of marks of graduate examination
  - ii. Valid proof of date of birth (as per government rule)
  - iii. Transfer/Migration Certificate
- c. Candidates granted admission under Reserved Category shall, in addition to the documents specified at (a) above, submit the following documents issued by competent government authorities:
  - i. Valid Caste Certificate
  - ii. Domicile Certificate (only for Maharashtra domicile candidates)
  - iii. Valid Non-Creamy Layer Certificate (for OBC candidates only)
  - iv. Certificate of Disability (for Physically Handicapped (PH) candidates)

In case a candidate fails to submit the requisite documents, the offer of admission is liable to be cancelled and the seat will be allotted to waitlisted candidate in the order of rank and preference.

## 6. Orientation Course in Basic Mathematics

On the basis of performance in the Entrance Test, the Institute shall identify students who require orientation in Basic Mathematics and Statistics. Such students shall be communicated separately via e-mail and shall be required to attend a **Special Orientation Course in Basic Mathematics** at the commencement of the academic session, from **July 22, 2019**. Attendance at this special orientation course shall be mandatory for such students.

## 7. Application for Admission to GIPE Hostel

- a. Limited accommodation is available at the GIPE hostels.
- b. Allotment of hostels will be subject to availability and on the basis of rank (reservation policy as may be applicable).
- c. Students seeking admission to GIPE hostels are required to fill in the Application Form for admission to GIPE hostels and mail the same to [hostels@gipe.ac.in](mailto:hostels@gipe.ac.in) at the earliest.

- d. Candidates shall pay the Hostel Fees, Mess Charges and Deposits as detailed below, by Demand Draft favouring 'Gokhale Institute of Politics and Economics', payable at Pune, at the time of document verification.

Electricity charges will be collected at the end of the year from each inmate of the hostel as per the reading of the sub-meter provided in the room/block, plus a general charge, on the basis of equal sharing, on account of use of hot-water, lighting of common facilities, etc.

8. Regular lectures shall commence on **Monday, July 22, 2019.**
9. **Cancellation of Admission - Cancellation Policy as per UGC guidelines:**
- If an applicant cancels admission **on or before 3-8-2019**, the Institute shall deduct processing charges equivalent of **10%** of the aggregate fees and refund the balance **90%**.
  - If an applicant cancels admission during the period **from 4-8-2019 to 2-9-2019**, the Institute shall deduct **20%** of the aggregate fees and refund the balance **80%**.
  - If an applicant cancels admission during the period **from 3-9-2019 to 17-9-2019**, the Institute shall deduct **50%** of the aggregate fees and refund the balance **50%**.
  - If an applicant cancels admission on or after **18-9-2019** then the full amount will be forfeited and the applicant shall be eligible for refund of only the refundable deposits.

In the case of candidates who cancel their admission, refund shall be arranged after deduction of admissible charges, via NEFT/RTGS only. **Refund against cancellation/shifting of programmes as per preference will be processed only after August 18, 2019.**
