ADMISSIONS to B.Sc.(Economics) Programme (Batch 2021-24)

Candidates who have applied for admission to B.Sc. (Economics) programme batch 2021-24 are hereby informed that the process of admission shall be as specified here below.

1. Result of the Entrance Exam has been declared on **July 7, 2021** and is available on our website.
2. Candidates shall be communicated offer of admission from **08-07-2021 via e-mail**, in the order of their merit rank.
3. Schedule of Iterations

4. Confirmation of admission and payment of Programme Fees

- a. Candidates who have been offered admission via e-mail communication **shall not be required to visit the Institute in person to confirm the admission**. Candidates who accept the offer and wish to confirm admission shall be required to pay the requisite fees through online payment gateway on or before the closing date for payment of Programme Fees, as per (3) above. The payment link will be shared on the candidates' email id. The payment link will be active only during the period given as per iterations. Once the payment link is deactivated, the candidates will be delisted from the merit rank list.

Schedule of Programme Fees* payable for B.Sc. Economics programme:

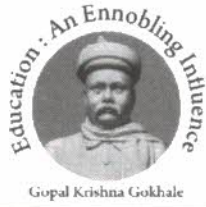
- c. If a candidate does not accept the offer of admission and pay the requisite Programme Fees within the specified time as per schedule at (3) above, the seat will be offered to the next candidate in order of merit rank.
- d. Admission shall be treated as provisionally confirmed only upon receipt of Programme Fees.
- e. The Academic Office shall verify receipt of Programme Fees and thereafter shall communicate via e-mail to the candidate confirming the receipt of payment and **Provisional Admission**.
- f. Candidates must note that their admission to the programme shall be provisional, until the required documents, as mentioned in the admissions brochure, to the Institute for the verification and validation by the designated Admission Committees.

5. Document Verification

- a. **Reserved Category (SC/ST/OBC/VJNT/DTNT/EWS/SBC)** who have confirmed admissions shall submit requisite documents via email to acadbsc+admission@gipe.ac.in with payment receipt.
- b. Physical verification of documents will be done in due course of time, as the Government SOP for COVID19. During physical verification of documents students shall carry with them the original, as well as a set of self-attested photocopies of the following documents:
 - i. Statement of marks of 12th examination
 - ii. Valid proof of date of birth (as per government rule)
 - iii. Transfer/Migration Certificate
- c. Candidates granted admission under Reserved Category shall, in addition to the documents specified at (a) above, submit the following documents issued by competent government authorities:
 - i. Valid Caste Certificate
 - ii. Valid Non-Creamy Layer Certificate (for OBC candidates only)
 - iii. Certificate of Disability (for Physically Handicapped (PH) candidates)

In case a candidate fails to submit the requisite documents, at the time of document verification the offer of admission is liable to be cancelled and the seat will be allotted to waitlisted candidate in the order of rank.

6. Induction program shall begin in the month of August 2021. Regular online lectures shall commence after a week.

7. Cancellation of Admission and refund of fees:

The candidates, who want to cancel "confirmed admission" will be entitled to refund of the aggregate fees (inclusive of tuition fees and non-tuition fees but exclusive of caution money and security deposit) as per the UGC guidelines as follows:

- i. If an applicant cancels admission **on or before 20-07-2021**, the Institute shall deduct processing charges equivalent of 10% of the aggregate fees and refund the balance 90%.
- ii. If an applicant cancels admission during the period **from 21-07-2021 to 31-07-2021**, the Institute shall deduct 20% of the aggregate fees and refund the balance 80%.
- iii. If an applicant cancels admission during the period **from 01-08-2021 to 20-08-2021**, the Institute shall deduct 50% of the aggregate fees and refund the balance 50%.
- iv. If an applicant cancels admission on or after **21-08-2021**, the Institute will forfeit the full amount. The applicant shall be eligible to get only 'refundable deposits' under the refund amount.

In the case of candidates who cancel their admission, refund shall be arranged after deduction of admissible charges, via NEFT/RTGS only. **Refund against cancellation will be processed only after September 10, 2021**
