- (i) Master's Degree in Economics with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) from an Indian University, or an equivalent degree from an accredited foreign university.
- (ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SET **or** who are or have been awarded a Ph.D. degree in accordance with the University Grants Commission (Minimum Standard and Procedures for Award of M.Phil./ Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SET:

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009 shall be governed by the provisions of the then existing Ordinances/ Bye-Laws/ Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/ Institutions subject to the fulfilment of the following conditions:

- a) The Ph.D. Degree of the candidate has been awarded in a regular mode only;
- b) The Ph.D. Thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. Viva-voce of the candidate has been conducted;
- d) The candidate has published two research papers from his/her research work, out of which at least one is in a referred journal; and
- e) The candidate has presented at least two papers based on his/her Ph.D. work in conferences/ seminars sponsored/ funded/ supported by the UGC/ ICSSR/ CSIR or any similar agency.

Note:

- 1. The fulfilment of the these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.
- 2. NET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SET is not conducted. However, Ph.D. Degree shall remain the minimum eligibility for appointment of Assistant Professor in such disciplines.

- (i) Master's Degree in Library Science, Library & Information Science or Documentation Science or an equivalent professional degree, with at least 55% marks (or an equivalent grade in a point scale wherever the grading system is followed).
- (ii) Consistently good academic record, with knowledge of computerization of a library.
- (iii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SET **or** who are or have been awarded a Ph.D. degree in accordance with the University Grants Commission (Minimum Standard and Procedures for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be.

NOTE:

- (1) Relaxation of 5% shall be allowed at the Bachelor's as well as the Master's level for the candidates belonging to Scheduled Castes/ Scheduled Tribes/Other Backward Classes (OBC) (Non-Creamy Layer)/Differently-abled (physically/ visually/ differently-abled), for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible only on the basis of the qualifying marks without including any grace marks.
- (2) Relaxation of 5% shall be provided (from 55% to 50% of the marks) to Ph. D. Degree holders who have obtained Master's Degree prior to 19 September, 1991.
- (3) Ph.D. Degree shall be a mandatory qualification for appointment to all the above advertised teaching posts under Government of Maharashtra.
- (4) The time taken by the candidates to acquire M.Phil. and/or Ph.D. Degree shall not be considered as teaching/research experience to be claimed for appointment to the teaching positions.
- (5) There shall be no incentives in form of advance increments for obtaining Ph.D./M.Phil. and other Higher Qualifications.
- (6) The Institute reserves the right to fill or not to fill up the advertised posts.

GENERAL INSTRUCTIONS TO THE CANDIDATES

- 1. Candidates applying for the post of ASSOCIATE PROFESSOR and/or ASSISTANT PROFESSOR should submit their duly filled in Application Form and latest Curriculum Vitae along with educational, experience and other related documents.
- 2. Candidates should submit with their applications, self-attested copies of the Degree or Diploma Certificates or other Certificates in support of their educational qualifications and experience and of the S.S.C. or equivalent Certificate in support of their date of birth. Original certificates should not be submitted along with the application but should be produced at the time of interview.
- 3. Domicile Certificate of Maharashtra State for availing reservation is a prerequisite.
- 4. Those candidates who had already applied against the Advt.- GIPE-ADVT-MAR-2023 dated March 14, 2023 are requested not to apply again as their earlier application will be considered for the due selection procedure. Please reapply in case of any changes in the application.
- 5. For reserved posts, only candidates belonging to reserved categories as specified in the advertisement shall be eligible to apply. Such candidates shall be required to submit with their application, copies of the Caste Certificate and Caste Validity Certificate issued by the competent authority.
- 6. Candidates belonging to reserved categories who are domiciled outside the Maharashtra State shall not be eligible for appointment against reserved posts under Government of Maharashtra; such candidates shall be treated as Open Category Candidates.
- 7. Candidates already in service should apply through proper channel with no objection certificate from current employer.
- 8. Candidates having degree from Foreign University should produce an equivalence certificate issued by the Association of Indian University (AIU) while applying.
- 9. Any change of candidate's address given in the application form should be communicated to the Registrar, Gokhale Institute of Politics and Economics, 846, Shivajinagar, Pune 411 004.
- 10. Incomplete applications will not be considered. Candidates furnishing incorrect/false/misleading information shall stand disqualified at any stage including during service.
- 11. Self-attested copies of papers and documents or reprints submitted with the application will not be returned.
- 12. Incomplete applications, as well as applications which are not submitted in the prescribed form along with the requisite testimonials, are liable to be rejected and no intimation in this regard will be sent to the candidates.

- 13. No correspondence will be entertained in respect of the advertisement, interview, selection, appointment etc. Canvassing in any form will lead to disqualification of the candidate.
- 14. No TA/DA will be admissible either for attending the interview or for joining the post.
- 15. A candidate should furnish all relevant information regarding his/her present service, legal proceedings or complaints, if any, pending in respect of his/her existing appointment, etc. If, at a later date, it is found that the candidate who has been offered appointment has furnished incomplete, incorrect or false information, then the appointment of such candidate shall be terminated forthwith.
