
1. Mr. Ayub Shaik, the representative from IQAC Cluster, commenced the meeting with a detailed introduction regarding IQAC CLUSTER and its potential to assist Gokhale Institute of Politics and Economics in five crucial audits: Energy Audit, Environmental Audit, Green Audit, Gender Audit, and Academic and Administrative Audit. He informed that IQAC CLUSTER would soon send a Letter

of Intent (LoI), giving the process details and information about the auditors involved. Subsequently, direct communication between the Institute and the auditors for Energy, Green, and Environment audits would be established to ensure a smooth execution of the audit process.

- 2. **Green, Energy and Environment Audit**: The Energy Audit, Green Audit and Environment Audit of the Institute will happen in the following way:
 - (a) The Green, Energy and Environment audits of the Institute will be conducted by IQAC Cluster, through their designated auditor, Ms. Nahida Shaik who was also present in the meeting virtually. She informed that she would be organizing a technical meeting within the coming week to discuss data requirements and other related information pertinent to these three audits. Based on the data and information provided by the Institute, IQACInstitute Cluster will furnish recommendations that can be incorporated as part of the Institute's annual plans.
 - (b) The auditors responsible for Energy, Green, and Environment audits will share the required format and provide instructions regarding the information and data that the Institute needs to furnish within the stipulated time frame.
 - (c) To streamline this process, an institutional portal will be created, facilitating the uploading of data. The auditors will meticulously study the submitted data and, if necessary, may request revisions or additional information
 - (d) Furthermore, the auditors will plan a site visit to the Institute in consultation with the Institute management. During the site visit, the auditors will assess the Institute's infrastructure and subsequently prepare a report.
 - (e) The draft report will be shared with the Institute, and upon reimbursement of the remaining funds, the final report will be provided.
 - (f) To streamline this process, an institutional portal will be created, facilitating the uploading of data. The auditors will meticulously study the submitted data and, if necessary, may request revisions or additional information.
- 3. Academic and Administrative Audit and Gender Audit: Gender and Academic and Administrative audits, Mr. Ayub Shaik confirmed that he would share the required formats by the end of today. possibility of extension for the subsequent year, 2023-2024. A team of three auditors from various regions of Maharashtra will visit the Institute on a predetermined date to conduct the audits. The Institute will be responsible for reimbursing the auditors' traveling allowances. Within two days following the site visit, the audited Academic and Administrative Audit (AAA) report will be presented to the Institute.

4. Overall, it is agreed that IQAC Cluster will guide and support our Institute throughout the audit process, ensuring a comprehensive assessment of our energy consumption, environmental practices, gender inclusivity, and academic and administrative systems. It is also agreed upon that cooperation from each and every department and faculty is required for successful completion of different audits and ensuring a smooth passage for NAAC accreditation.
