

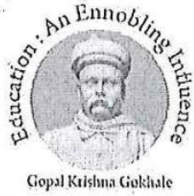

Terms and Conditions:

1. As given in your quotation, you will be required to do the garden waste treatment in 600 sq.ft. in 8 pits.
2. As the service cost includes transport of the materials and you will not charge anything extra for transportation purpose.
3. Once the set-up is complete, you are supposed to provide training for a period of three months (all total six visits) to one of our staff members without any additional charge.
4. You will be given 50 % of the total cost quoted by you along with this work order; the remaining amount will be given to once the composting facility becomes fully operational.

Minutes of the Local Purchase Committee Meeting held on June 22, 2020 in the Institute

The meeting of the Local Purchase Committee of the Institute was held on June 22, 2020 at 4.00 p.m. at the Offg. Director's Office in the Institute. The following members were present:

1. Prof. Rajas Parchure – Offg. Director, *Chairman*
2. Dr. P N Rath – Offg. Registrar, *Member*
3. Mrs. Ashwini A. Joglekar – Finance & Accounts Officer, *Member*
4. Shri Pramod Joshi, Information Scientist, *Member*
5. Shri S. N. Deshpande – Office Superintendent, *Member*
6. Dr. Sunil Bhosale, Campus Secretary, *Invitee*

Following decisions have been taken in the meeting of the purchase Committee:

1. **Purchases to be made for Spreading of COVID 19 Virus in the Institute** : The Institute noted that to prevent spread of the Pandemic COVID 19 Virus in the City, the Institute has already procured some items like thermal scanners, sanitizers and Sodium Hypochlorite mixed spray and some masks for the housekeeping boys, etc. However, as the Virus is spreading in the threatening way, the following purchases need to be made by the Institute as preventive measures to see that the Institute remains virus free.
 - a. Sanitizer Dispensing Machine: The Committee has resolved to purchase one sensor operated sanitizer dispensing machine with a capacity of one litre/- the cost of which comes to Rs. 5200/- per machine plus GST as applicable. The Committee has also approved purchase of one cell operated sanitizer dispensing machine at the cost of Rs.4500/- plus GST as applicable.
 - b. N95 Masks for the Staff Members: The Committee noted a quotation from KB Associates for different types of masks for the staff members and resolved that instead of N95 masks, Institute may purchase 2 pieces of 6 layered re-usable masks at Rs.180/- per piece for the Health Centre as given in the quotation.
2. **Purchase of one Mobile phone with High End Camera**: The Committee considered a suggestion from IQAC Committee to purchase one good camera for capturing different events and other images from the Institute to upload on the Website and resolved that instead of a Camera, the Institute may purchase one mobile phone with very good quality camera so that it will be easier to transmit the images to other media. In this connection the Committee authorized Mr. Pramod Joshi to find out the suitable mobile phone with good quality camera from a reputed company and place the same in the next meeting of the Committee.
3. **Proposal for Composting of Garden Waste in the Residential Campus**: The Committee considered a proposal received from INORA Biotech Pvt. Ltd., Pune for composting of garden waste in the Residential Campus and resolved to approve the same with total project startup cost of Rs. 1,00,823/- including three months' maintenance cost with GST. The Committee also considered purchase of maintenance material for three months for the same at Rs. 15048/- including GST.




- 4. Fixing Tin Sheets on the Compound Wall of the Residential Campus:** The Committee considered the need for heightening of certain portion of the compound wall of the residential campus and resolved that the height may be increased by fixing tin sheets above the present wall. The Committee asked Dr. Sunil Bhosale, Campus Secretary to contact different contractors and place the proposal in the next meeting of the Committee.
- 5. Purchase of Camera and Headphones for Academic Section:** The Committee considered a proposal for purchase of camera and headphones for the Academic Section in view of the commencement of online examination on July 1, 2020 and resolved to approve the same in the same rate as was purchased earlier for RM Coursework during May 2020. The Committee also approved a request of Dr. Naresh Bodkhe, Associate Professor for purchase of one headphone for office use.

The meeting ended with a vote of thanks to the Chair.

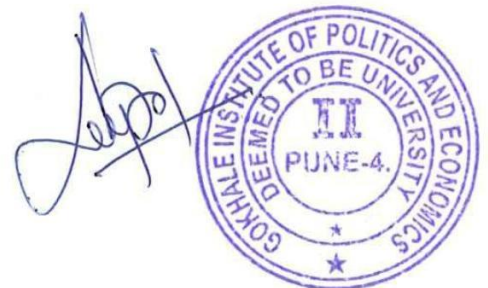

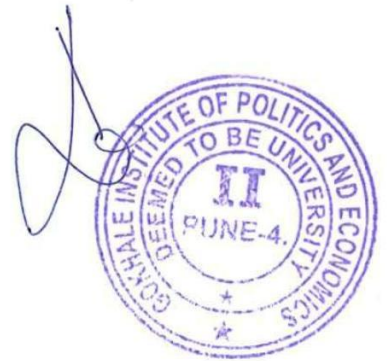
