In pursuance of clause (3) of article 348 of the Constitution of India, the following translation in English of the Maharashtra Private Professional Educational Institutions (Reservation of seats for admission for Scheduled Castes, Scheduled Tribes, De-notified Tribes (Vimukta Jatis), Nomadic Tribes and Other Backward Classes Act, 2006 (Mah. XXX of 2006), is hereby published under the authority of the Governor.

#### MAHARASHTRA ACT No. XXX OF 2006.

(First published, after having received the assent of the Governor in the "Maharashtra Government Gazette", on the 1st August 2006).

An Act to make special provisions for reservation of seats for admission for Scheduled Castes, Scheduled Tribes, De-notified Tribes (Vimukta Jatis), Nomadic Tribes and Other Backward Classes in Private Professional Educational Institutions; and for matters connected therewith or incidental thereto.

WHEREAS the Supreme Court, in the case of P. A. Inamdar and Others versus State of Maharashtra (reported in (2005) 6 SCC 537), has held that neither can the policy of reservation be enforced by the State nor can any quota or percentage of admission be carved out to be appropriated by the State in Private Professional Educational Institutions;

AND WHEREAS in order to protect the interests of any socially and educationally backward classes of citizens or the Scheduled Castes or the Scheduled Tribes, article 15 of the Constitution of India has

been amended by the Constitution (Ninety-third Amendment) Act, 2005, by adding clause (5) thereto, which empowers the State to make, by law, a special provision for the advancement of those classes, castes and tribes, in so far as such special provisions relate to their admission to educational institutions, including private educational institutions, whether aided by the State or not, other than the minority educational institutions referred to in clause (1) of article 30 of the Constitution;

AND WHEREAS both Houses of the State Legislature were not in session;

AND WHEREAS the Governor of Maharashtra was satisfied that circumstances existed which rendered it necessary for him to take immediate action to make, by law, special provisions for reservation of seats for admission for Scheduled Castes, Scheduled Tribes, De-notified Tribes (Vimukta Jatis), Nomadic Tribes and Other Backward Classes in Private Professional Educational Institutions; and for matters connected therewith or incidental thereto; and, therefore, promulgated the Maharashtra Private Professional Mah. Educational Institutions (Reservation of seats for admission for Ord. V Scheduled Castes, Scheduled Tribes, De-notified Tribes (Vimukta of Jatis), Nomadic Tribes and Other Backward Classes) Ordinance, 2006, on the 16th June 2006:

AND WHEREAS it is expedient to replace the said Ordinance by an Act of the State Legislature; it is hereby enacted in the Fifty-seventh Year of the Republic of India as follows :-

Short title,

- 1. (1) This Act may be called the Maharashtra Private Professional extent and Educational Institutions (Reservation of seats for admission for commence- Scheduled Castes, Scheduled Tribes, De-notified Tribes (Vimukta ment. Jatis), Nomadic Tribes and Other Backward Classes) Act, 2006.
  - (2) It shall extend to the whole of the State of Maharashtra.
  - (3) It shall be deemed to have come into force on the 16th June 2006.

Definitions.

- 2. In this Act, unless the context otherwise requires,—
- (a) "Aided Private Professional Educational Institution" means a Private Professional Educational Institution, excluding a Minority Educational Institution referred to in clause (1) of article 30 of the Constitution, receiving recurring financial aid or assistance in whole or in part from the Government, or from any body under the control of the Government;
- (b) "Appropriate Authority" means, the Medical Council of India, the Dental Council of India, the Central Council of Indian Medicine, the All India Council of Technical Education, and includes any other authority established by law that governs or controls the conduct of a particular professional course or educational discipline;



- (c) "Creamy Layer" means the category of 'Creamy Layer' as declared by the Social Justice, Cultural Affairs and Special Assistance Department of the Government, on the basis of income, by general or special orders, issued from time to time;
- (d) "De-notified Tribes (Vimukta Jatis)" means the Tribes declared as such by the Government, from time to time;
  - (e) "Government" means the Government of Maharashtra;
- (f) "Minority Educational Institution" means a Private Professional Educational Institution administered, managed and controlled by a minority, and shall include any such educational institution declared by the Government to be an institution entitled to enjoy the protection granted under clause (1) of article 30 of the Constitution;
- (g) "Nomadic Tribes" means the Tribes wandering from place to place in search of their livelihood, as declared by the Government, from time to time;
- (h) "Other Backward Classes" means any socially and educationally backward classes of citizens as declared by the Government and includes Other Backward Classes declared by the Government of India in relation to the State of Maharashtra;
- (i) "Private Professional Educational Institution" means any College, School, Institute, Institution or other body, by whatever name called, conducting any professional course or courses approved or recognized by the Appropriate Authority and affiliated to any University, but shall not include any such institution established, maintained or administered by the Central Government, any State Government, any local authority or institution declared to be Deemed University under section 3 of the University Grants Commission Act, 1956;

- (j) "Professional Course" means any educational course of study notified as such, from time to time, by the Government in the Official Gazette;
- (k) "prescribed" means prescribed by the rules framed by the Government under this Act;
- (l) "Reserved Category" means the category of candidates belonging to—
  - (i) the Scheduled Castes and the Scheduled Tribes;
  - (ii) the De-notified Tribes (Vimukta Jatis), Nomadic Tribes and Other Backward Classes and who are not falling in Cream Layer;

- (m) "Sanctioned Intake" means the total number of seats sanctioned or approved by the Appropriate Authority for-admitting candidates in a single academic year in each Professional Course of study or discipline in a Private Professional Educational Institution:
- (n) "Scheduled Castes" and "Scheduled Tribes" shall have the meanings respectively assigned to them in clauses (24) and (25) of article 366 of the Constitution;
- (o) "Unaided Private Professional Educational Institution" means a Private Professional Educational Institution, not being an Aided Private Professional Educational Institution;
- (p) "University" means the Maharashtra University of Health Sciences constituted under the Maharashtra University of Health Mah X Sciences Act, 1998, or any other University constituted or deemed to have been constituted under the Maharashtra Universities Act, 1994, but does not include any institution declared to be Deemed University under section 3 of the University Grants Commission Act, 1956.

Applicability.

3. This Act shall apply to all Private Professional Educational Institutions in the State, excluding the Minority Educational Institutions.

Reservation in Aided Private Professional Institutions.

- 4. (1) In every Aided Private Professional Educational Institution, seats equal to fifty per cent. of the Sanctioned Intake of each Professional Course shall be reserved for candidates belonging to Educational the Reserved Category.
  - (2) The seats reserved for candidates belonging to the Reserved Category under sub-section (1) shall be filled in by admitting candidates belonging to the Scheduled Castes, Scheduled Tribes, De-notified Tribes (Vimukta Jatis), Nomadic Tribes and Other Backward Classes, respectively, in the proportion specified in the Table below :--

Note.—The candidates belonging to the Special Backward Category shall be considered from and out of their respective original/parent Reserved Category such as Other Backward Classes:

Provided that, if candidates belonging to the Scheduled Castes, Scheduled Tribes, De-notified Tribes (A), Nomadic Tribes (B), Nomadic Tribes (C), Nomadic Tribes (D) or Other Backward Classes are not available to fill in the seats reserved for the said Castes, Tribes or Classes, in the same academic year, the seats shall be filled in, in such manner as may be specified, by Government by issuing an Order in the Official Gazette, from time to time.

Explanation.—For the purposes of this section,—

- (i) "De-notified Tribes (A)", "Nomadic Tribes (B)", "Nomadic Tribes (C)" and "Nomadic Tribes (D)" shall mean such Tribes or sub-Tribes, declared by Government, by general or special orders issued in this behalf, from time to time, to be "the De-notified Tribes (A)", "Nomadic Tribes (B) ", "Nomadic Tribes (C)" and "Nomadic Tribes (D)";
- (ii) "Special Backward Category" means socially and educationally backward classes of citizens declared as "Special Backward Category" by the Government.
- 5. (1) In every Unaided Private Professional Educational Institutions, Reservation the seats to be reserved for candidates belonging to the Reserved Category shall be such as may be notified by the Government from time to time in the Official Gazette, but shall not exceed fifty per cent. of the Sanctioned Educational Intake of any particular Professional Course.

Professional Institutions.

- (2) Out of the seats reserved under sub-section (1) for the candidates belonging to the Reserved Category, the seats to be filled in by admitting candidates belonging to the Scheduled Castes, Scheduled Tribes, De-notified Tribes (Vimukta Jatis), Nomadic Tribes and Other Backward Classes, respectively, shall be in the same inter se proportion, and in the manner, specified in sub-section (2) of section 4.
- 6. Any admission made in contravention of the provisions of this Act Irregular shall be void.

7. Whoever contravenes the provisions of this Act or the rules made Penalty. thereunder shall, on conviction, be punished with an imprisonment which may extend to three years and with a fine which shall not be less than twenty lakh rupees but which may extend to one crore rupees.

Protection good faith.

8. No suit, prosecution or other legal proceedings shall lie against of action any authority or person for anything done or purported to have been taken in done in good faith in pursuance of the provisions of this Act or the rules made thereunder.

Power to rules.

- 9. (1) The Government may, by notification in the Official Gazette, make make rules to carry out the purposes of this Act.
  - (2) Every rule made under this Act shall be laid, as soon as may be, after it is made, before each House of the State Legislature, while it is in session for a total period of thirty days, which may be comprised in one session or in two or more successive sessions, and if, before the expiry of the session in which it is so laid or the sessions immediately following, both Houses agree in making any modification in the rule or both Houses agree that the rule should not be made, and notify their decision to that effect in the Official Gazette, the rule shall, from the date of publication of such decision in the Official Gazette, have effect only in such modified form or be of no effect, as the case may be; so, however, that any such modification or annulment shall be without prejudice to the validity of anything previously done or omitted to be done under that rule.

Provisions addition to any other law.

10. The provisions of this Act shall be in addition to and not in of the Act derogation of the provisions contained in any other law for the time to be in being in force.

Provisions prohibit Minority Educational Institutions from making reservations.

11. Notwithstanding anything contained in any other provisions of not to this Act, any Minority Educational Institution, whether aided or not, may provide for reservation in admissions to Professional Courses for candidates belonging to the Reserved Category.

12. (1) If any difficulty arises in giving effect to the provisions of this remove Act, the Government may, as occasion arises, by an order published in difficulty. the Official Gazette, do anything not inconsistent with the provisions of this Act, which appears to it to be necessary or expedient for removing the difficulty:

> Provided that, no such order shall be made after the expiry of a period of two years from the date of commencement of this Act.

> (2) Every order made under this section shall be laid, as soon as may be, after it is made, before each House of the State Legislature.



13. (1) The Maharashtra Private Professional Educational Repeal of Mah. Ord. Institutions (Reservation of seats for admission for Scheduled Castes, Mah. Ord. V of Scheduled Tribes, De-notified Tribes (Vimukta Jatis), Nomadic Tribes V of 2006 2006. and Other Backward Classes) Ordinance, 2006, is hereby repealed.

(2) Notwithstanding such repeal anything done or any action taken (including any notification or order issued), under the said Ordinance, shall be deemed to have been done, taken or issued, as the case may be, under the corresponding provisions of this Act.

#### OFFICE MEMORANDUM

Subject: Reservation for Economically Weaker Sections (EWSs) for admission in Central Educational Institutions.

In accordance with the provisions of the Constitution (One Hundred and Third Amendment) Act 2019, and the reference of Ministry of Social Justice and Empowerment vide OM No. 20013/01/2018-BC-II dated 17th January 2019, enabling provision of reservation for the Economically Weaker Sections (EWSs) who are not covered under the existing scheme of reservations for the Scheduled Castes, the Scheduled Tribes and the Socially and Educationally Backward Classes, it has been decided to provide reservation in admission to educational institutions subject to a maximum of ten per cent of the total seats in each category. This would not apply to the minority educational institutions referred to in clause (1) of Article 30 of the Constitution of India.

2. The provision of reservations to the Economically Weaker Sections shall be in accordance with the directions contained in the OM No. 20013/01/2018-BC-II dated 17th January 2019 of the Ministry of Social Justice & Empowerment and shall be subject to the following:

a) The reservations shall be provided to EWSs for admission in Central Educational Institutions, (as defined in clause (d) of section (2) of The Central Educational Institutions (Reservation in Admission) Act, 2006) from the academic year 2019-20 onwards.

b) The above reservation would not be applicable to the 8 institutions of excellence, research institutions, institutions of national & strategic importance as specified in the Schedule to The Central Educational Institutions (Reservation in Admission) Act, 2006, as amended from time to time, and appended to this OM, and to the minority educational institutions referred to in clause (1) of article 30 of the Constitution.

c) Every Central Educational Institution shall, with the prior approval of the appropriate authority (as defined in clause (c) of section 2 of The Central Educational Institutions (Reservation in Admission) Act, 2006), increase the number of seats over and above its annual permitted strength in each branch of





study or faculty so that the number of seats available, excluding those reserved for the persons belonging to the EWSs, is not less than the number of such seats available, in each category, for the academic session immediately preceding the date of the coming into force of this O.M.

d) Where, on a representation by any Central Educational Institution, the appropriate authority is satisfied that for reasons of financial, physical or academic limitations or in order to maintain the standards of education, the annual permitted strength in any branch of study or faculty of such institution cannot be increased for the academic session following the commencement of this Act, it may permit such institution to increase the annual permitted strength over a maximum period of two years beginning with the academic session following the commencement of this Act; and then, the extent of reservation for the Economically Weaker Sections shall be limited for that academic session in such manner that the number of seats made available to the Economically Weaker Sections for each academic session shall not reduce the number and the percentage of reservations provided for SC/ST/OBC categories.

e) The scheme for implementing the reservation for the EWS shall be displayed on the website of the institution as soon as possible, but no later than 31st March

2019.

- 3. The Chairman UGC, Chairman AICTE and Chairperson NCTE and the Bureau Heads of the Department of Higher Education in the Ministry of Human Resource Development responsible for management of the Institutions of National Importance are requested to ensure immediate compliance of this OM.
- 4. This issues with the approval of the Minister for Human Resource Development.



## अनाथांच्या १% आरक्षणाच्या धोरणात बदल करणेबाबत

#### प्रस्तावना:-

बाल न्याय (मुलांची काळजी व संरक्षण) अधिनियम, २०१५ अन्वये काळजी व संरक्षणाची गरज असलेल्या अनाथ, निराधार बालकांना पोलीस, स्वयंसेवी संस्था, पालक यांचेकडून बाल कल्याण समितीमार्फत बालगृहात प्रवेश दिला जातो. ० ते १८ वयोगटातील अशा मुलांना बालगृहामध्ये अत्र, वस्र, निवारा, आरोग्य सुविधा, शिक्षण, प्रशिक्षण इत्यादी सुविधा पुरिवल्या जातात व पुनर्वसनासाठी प्रयत्न केले जातात. अनाथ मुलांना त्यांचा संस्थेतील कालावधी संपल्यानंतर संस्थेच्या बाहेर पडल्यानंतर अनेक समस्यांना तोंड द्यावे लागते. अनाथ मुलांची जात नक्की माहिती नसल्याने, त्यांना कोणत्या एका विशिष्ट प्रवर्गात समाविष्ट करता येत नाही. जातीचा दाखला नसल्यामुळे, त्यांना विविध शासकीय लाभापासून वंचित रहावे लागते. त्यामुळे त्यांचा भावी आयुष्यात अनेक अडचणी निर्माण होतात. अनाथ मुलांकडे कोणतीही कागदपत्रे व पुरावे नसल्यामुळे, त्यांना जातीचे प्रमाणपत्र मिळत नाही व त्यामुळे त्यांना विविध शासकीय सवलतींपासून वंचित रहावे लागते. त्यामुळे अनाथ मुलांना राज्य शासनाच्या विविध सवलतींचा लाभ धेता यावा, याकरीता आरक्षण लागू करणेबाबतचा प्रस्ताव शासनाच्या विचाराधीन होता. त्यानुसार दिनांक १७ जानेवारी, २०१८ रोजी झालेल्या मंत्रिमंडळाच्या बैठकीतील निर्णयानुसार वाचा क्र.२ च्या शासन निर्णयान्वये, अनाथ मुलांना खुल्या प्रवर्गातून शिक्षण व नोकरी यामध्ये १% समांतर आरक्षण लागू करण्यात आले आहे.तर वाचा क्र.३ नुसार अनाथ आरक्षणाच्या अनुषंगाने मार्गदर्शक सूचना निर्गमीत करण्यात आलेल्या आहेत.

2. अनाथ आरक्षणासंबंधीत संदर्भीय क्र. २ येथील दि. २/०४/२०१८ च्या शासन निर्णयात नमूद अनाथांच्या व्याख्येत बदल करण्याबाबत तसेच अनाथांची तीन प्रकारांमध्ये वर्गवारी करणेबाबतचा प्रस्ताव शासनाच्या विचाराधीन होता. त्यानुसार सुधारित प्रस्ताव सामान्य प्रशासन विभागास सादर करण्यात आला होता. अनाथ आरक्षण या विषयाच्या अनुषंगाने अनाथांना खुल्या प्रवर्गातून १% आरक्षण लागू करण्याऐवजी त्यांना दिव्यांगांच्या धर्तीवर १% आरक्षण निश्चित करणेबाबत सामान्य प्रशासन विभाग, मंत्रालय, मुंबई यांनी सुचित केले होते. त्यानुसार अनाथांना १% आरक्षण लागू करणे, अनाथांच्या व्याख्येमध्ये बदल करणे, अनाथांची तीन प्रकारामध्ये वर्गवारी करणे, अनाथ प्रमाणपत्र नमून्यात बदल करणे व यानुषंगाने आरक्षणीसंबंधीत उपरोक्त वाचा क्र.१ ते ३ मधील शासन निर्णय अधिक्रमीत करून एकच सर्वसमावेशक शासन निर्णय निर्मित करण्याची बाब शासनाच्या विचाराधीन होती.

#### शासन निर्णय:-

बाल न्याय (मुलांची काळजी व संरक्षण) अधिनियम, २०१५ अन्वये काळजी व संरक्षणाची गरज असलेल्या अनाथ, निराधार बालकांना संस्थेतून बाहेर पडल्यानंतर जातीचा दाखला नसल्यामुळे विविध शासकीय लाभांपासून वंचित रहावे लागते. त्यामुळे अनाथ मुलांना राज्य शासनाच्या विविध सवलतींचा लाभ घेता यावा याकरीता खालीलप्रमाणे वर्गीकृत अनाथांना शिक्षण व नोकरी यामध्ये १% आरक्षण लागू करण्यास मान्यता देण्यात येत आहे.

- 9) "अ" या प्रवर्गामध्ये पुर्णत: अनाथ असलेल्या बालकांचा, ज्यांच्या आई-वडील, भाऊ-बहीण, जवळचे नातेवाईक,गाव, तालुका,पत्ता याबाबत काहीही माहिती उपलब्ध नाही आणि त्या बालकांचे पालनपोषण बालकांच्या काळजीसाठी कार्यरत संस्थेत/ अनाथालयात झाले आहे, अशी बालके.
- २) "ब" या प्रवर्गामध्ये ज्या मुलाचे आई-वडील यांचे निधन झालेले आहे तथापि, त्यांच्या नातेवाईकांबाबत माहिती उपलब्ध असून त्यांच्या कागदपत्रावर जातीचा उल्लेख करण्यात आलेला आहे आणि त्या बालकांचे पालनपोषण बालकांसाठी कार्यरत संस्थेत/ अनाथालयात झाले आहे, अशी बालके.
- 3) "क" या प्रवर्गामध्ये ज्या मुलाचे आई-वडील यांचे निधन झाले आहे परंतू त्या मुलाचे इतर नातेवाईक जिवंत असून बालकाचे संगोपन नातेवाईकांकडे झालेले असून बालकाच्या जातीबाबतचीही माहिती उपलब्ध आहे, अशी बालके.

## २. अटी व शर्ती/ कार्यपध्दती :-

- १) महिला व बाल विकास विभागाकडून ज्या अनाथ मुलांना अनाथ प्रमाणपत्र देण्यात आलेली आहेत अशी बालके आरक्षणासाठी पात्र राहतील. तथापि, ज्या अनाथ मुलाच्या आई-वडीलांचे निधन त्या मुलाच्या वयाची १८ वर्ष पुर्ण होण्यापुर्वी झाले असेल अशाच बालकांना आरक्षण अनुज्ञेय राहील.



#### प्रस्तावना:-

संसदेने संविधानात १०३ वी घटना दुरुस्ती कायदा, २०१९ पारित केलेला आहे. त्याद्वारे भारताच्या संविधानाच्या अनुच्छेद १५ व १६ मध्ये सुधारणा करण्यात आलेली आहे. उक्त घटना दुरुस्तीन्वये राज्य घटनेच्या अनुच्छेद १५ मध्ये खंड (६) चा समावेश करण्यात आला आहे. या सुधारणेनुसार अनुच्छेद १५ च्या खंड (४) व (५) मध्ये नमूद वर्गाव्यतिरिक्त आर्थिकदृष्ट्या दुर्बल घटकांच्या नागरिकांच्या प्रगतीसाठी कोणतीही विशेष तरतूद करता येईल, तसेच खंड (४) व (५) मध्ये नमूद वर्गाव्यतिरिक्त आर्थिकदृष्ट्या दुर्बल घटकांसाठी अनुच्छेद ३० च्या खंड (१) मध्ये संदर्भित अल्पसंख्यांक शैक्षणिक संस्थांखेरीज, अन्य शैक्षणिक संस्थांमध्ये तसेच खाजगी शैक्षणिक संस्थांमध्ये–मग त्या राज्य शासनाकडून अनुदान प्राप्त असोत अगर अनुदान प्राप्त नसोत–प्रवेश देण्याशी संबंधित असतील तेथवर राज्य शासनास १० टक्के पर्यंत जागा आरक्षित करता येतील. अनुच्छेद १५ मधील कोणत्याही तरतूदीचा किंवा अनुच्छेद १९ च्या खंड (१) च्या उप खंड (७) किंवा अनुच्छेद २९ च्या खंड (२) चा वरीलप्रमाणे विशेष तरतूद करण्यास राज्यास प्रतिबंध होणार नाही. हे आरक्षण सध्या मागासवर्गीयांसाठी विहित असलेल्या आरक्षणाव्यतिरिक्त राहील. (स्पष्टीकरण: अनुच्छेद १५ व १६ करिता आर्थिकदृष्टया दुर्बल घटक म्हणजे राज्य शासना वेळोवेळी आर्थिक उत्पन्न आणि अन्य आर्थिक दुर्बलतेच्या आधारावर अधिसूचित करेल त्याप्रमाणे राहील).

तसेच संविधानाच्या अनुच्छेद १६ मध्ये सुधारणा करुन त्यामध्ये खंड (६) चा समावेश करुन त्याद्वारे शासकीय सेवांमध्ये अनुच्छेद १६ च्या खंड (४) मध्ये नमूद केलेल्या आरक्षणाव्यतिरिक्त आर्थिकदृष्टया दुर्बल घटकांसाठी १०% पर्यंत आरक्षण ठेवण्यास राज्यास प्रतिबंध होणार नाही अशी तरतूद करण्यात आली आहे. संसदेने पारित केलेला घटना दुरुस्तीचा कायदा हा दिनांक १४ जानेवारी, २०१९ रोजीच्या राजपत्रान्वये अंमलात आला आहे.

सदर घटना दुरूस्तीची राज्यात अंमलबजावणी करणे आवश्यक आहे. ही बाब विचारात घेता राज्यातही खुल्या प्रवर्गातील आर्थिकदृष्ट्या दुर्बल घटकांसाठी शासकीय /निमशासकीय सेवा व शासनाचे उपक्रम यामधील सेवेसाठी व अल्पसंख्याक शैक्षणिक संस्था वगळता शासकीय, खाजगी, अनुदानित, विना अनुदानित संस्थामध्ये प्रवेशासाठी १०% आरक्षण ठेवण्याचा निर्णय शासनाच्या विचाराधीन होता. त्यानुसार राज्य शासन पुढीलप्रमाणे निर्णय घेत आहे:-

#### शासन निर्णय:-

भारतीय संविधानातील अनुच्छेद १५ (४) व (५) आणि अनुच्छेद १६ (४) अन्वये आरक्षणाचा लाभ देण्यात आलेल्या प्रवर्गाव्यतिरिक्त (मागासवर्गीय) राज्यातील आर्थिकदृष्ट्या दुर्बल घटकांसाठी, शासकीय शैक्षणिक संस्था/ अनुदानित विद्यालये, महाविद्यालये, सर्व उच्च शिक्षण देणाऱ्या शैक्षणिक संस्था, विना अनुदानित विद्यालये, महाविद्यालये व शैक्षणिक संस्था यामध्ये एकूण प्रवेश द्यावयाच्या जागांमध्ये १० % आरक्षण विहित करण्यात येत आहे. सदर आरक्षण राज्यघटनेच्या अनुच्छेद ३० च्या खंड (१) मध्ये संदर्भीत अल्पसंख्याक संस्थाना लागू होणार नाही.

तसेच राज्यातील आर्थिकदृष्टया दुर्बल घटकांसाठी शासकीय आस्थापना, निमशासकीय आस्थापना, मंडळे/महामंडळे/नागरी स्थानिक स्वराज्य संस्था/ग्रामीण स्थानिक स्वराज्य संस्था, प्राधिकरणे यांच्या आस्थापनावरील नियुक्तीसाठी सरळसेवेच्या पदांमध्ये १० % आरक्षण विहित करण्यात येत आहे.

# २. आर्थिकदृष्टया दुर्बल घटकासाठीच्या आरक्षणाचा लाभ खालील अटींच्या अधीन अनुज्ञेय राहील :-

(अ) राज्यातील आर्थिकदृष्टिया दुर्बल घटकासाठी ज्या व्यक्तीच्या जातींचा महाराष्ट्र राज्य लोकसेवा अनुसूचित जाती, अनुसूचित जमाती, निरिधसूचित जमाती (वि.जा.) भटक्या जमाती, विशेष मागास प्रवर्ग आणि इतर मागासवर्ग यांच्यासाठी आरक्षण अधिनियम, २००१ (सन २००४ चा महाराष्ट्र अधिनियम क्रमांक ८) व महाराष्ट्र राज्य सामाजिक आणि शैक्षणिक मागास (एसईबीसी) वर्गाकरिता (राज्यातील शैक्षणिक संस्थांमधील जागांच्या प्रवेशाचे आणि राज्याच्या नियंत्रणाखालील लोकसेवांमधील नियुक्त्यांचे किंवा पदांचे ) आरक्षण अधिनियम,२०१८ (सन २०१८ चा महाराष्ट्र अधिनियम क्रमांक ६२) यामधील प्रवर्गांमध्ये समावेश नाही त्यांच्यासाठी शासकीय शैक्षणिक संस्था/ अनुदानित विद्यालये, महाविद्यालये, शैक्षणिक संस्था, विना अनुदानित विद्यालये, महाविद्यालये, शैक्षणिक संस्था यामध्ये एकूण प्रवेश द्यावयाच्या जागांमध्ये १०% आरक्षण विहित करण्यात येत आहे. सदर आरक्षण राज्य घटनेच्या अनुच्छेद ३० च्या खंड (१) मध्ये संदर्भीत अल्पसंख्याक शैक्षणिक संस्थाना लागू होणार नाही.

तसेच शासकीय आस्थापना, निमशासकीय आस्थापना, मंडळे/महामंडळे/नागरी स्थानिक स्वराज्य संस्था/ग्रामिण स्थानिक स्वराज्य संस्था, प्राधिकरणे यांच्या आस्थापनेवरील सरळसेवेच्या पदांच्या सर्व संवर्गातील नियुक्तीसाठी १०% पदे ही आर्थिकदृष्टया दुर्बल घटकांसाठी राखीव राहतील.

(ब) हे १०% आरक्षण राज्यात सध्या महाराष्ट्र राज्य लोकसेवा अनुसूचित जाती, अनुसूचित जमाती, निरिधसूचित जमाती (वि.जा.), भटक्या जमाती, विशेष मागास प्रवर्ग आणि इतर मागासवर्ग यांच्यासाठी आरक्षण अधिनियम, २००१ (सन २००४ चा महाराष्ट्र अधिनियम क्रमांक ८) अन्वये विहित करण्यात आलेल्या मागासवर्गांसाठी व महाराष्ट्र राज्य सामाजिक आणि शैक्षणिक मागास (एसईबीसी) वर्गाकरिता (राज्यातील शैक्षणिक संस्थांमधील जागांच्या प्रवेशाचे आणि राज्याच्या नियंत्रणाखालील लोकसेवांमधील नियुक्त्यांचे किंवा

पदांचे) आरक्षण अधिनियम,२०१८ (सन २०१८ चा महाराष्ट्र अधिनियम क्रमांक ६२) अन्वये सामाजिक व शैक्षणिकदृष्टया मागास घटकांसाठी विहित करण्यात आलेल्या आरक्षणाव्यतिरिक्त राहील.

- (क) आर्थिकदृष्टया दुर्बल घटकांच्या आरक्षणाच्या लाभासाठी पात्रता:-
  - (१) ज्या अर्जदाराच्या/ उमेदवाराच्या कुटुंबाचे एकत्रित वार्षिक उत्पन्न रु. ८ लाखाच्या आत असेल त्या अर्जदारास/ उमेदवारास आर्थिकदृष्ट्या दुर्बल समजण्यात येईल व या आरक्षणाच्या लाभासाठी तो पात्र राहील.
  - (२) या आरक्षणाच्या लाभासाठी कुटुंब म्हणजे अर्जदाराचे/ उमेदवाराचे आई -वडील व १८ वर्षा खालील भावंडे तसेच अर्जदाराची/ उमेदवाराची १८ वर्षाखालील मुले व पती/पत्नी यांचा समावेश होईल. कुटुंबाच्या एकत्रित उत्पन्नात त्याच्या कुटुंबातील सदस्यांच्या सर्व स्रोतांमधून मिळणा-या उत्पन्नाचा समावेश असेल म्हणजेच वेतन, कृषी उत्पन्न, उदयोग-व्यवसाय या व इतर सर्व मार्गातून होणारे, अर्ज दाखल करण्याच्या दिनांकाच्या मार्गील आर्थिक वर्षाचे वार्षिक उत्पन्न एकत्रितपणे रु. ८ लाखापेक्षा कमी असावे.
  - (३) आर्थिक दुर्बल घटकासाठीच्या आरक्षणाचा लाभ घेण्यासाठी या सोबत विहित करण्यात आलेल्या नमुन्यात (परिशिष्ट-अ) सक्षम प्राधिका-याचे पात्रता प्रमाणपत्र सादर करणे बंधनकारक राहील. तसेच यासाठी सादर करावयाच्या अर्जाचा नमुना (परिशिष्ट-ब), अर्जासोबत जोडावयाची कागदपत्रे / पुरावा (परिशिष्ट-क) आणि घोषणापत्र (परिशिष्ट-ड) सोबत जोडण्यात आलेल्या नमुन्याप्रमाणे असणे आवश्यक राहील.
  - (४) या आरक्षणाचा लाभ घेण्यासाठी ती व्यक्ती किंवा तिचे कुटुंबीय महाराष्ट्र राज्यात दि. १३ ऑक्टोबर १९६७ रोजी किंवा त्यापूर्वीचे रहिवासी असणे आवश्यक राहील.
  - (५) सदर प्रवर्गातील उमेदवारांना वय, परीक्षा फी व इतर अनुज्ञेय सवलती ह्या इतर मागास प्रवर्गास राज्य शासनाने वेळोवेळी लागू केलेल्या नियमानुसार राहतील.

# (ड) पात्रता प्रमाणपत्रासंबंधातील कार्यपद्धती –

- (१) आर्थिक दुर्बल घटकासाठीच्या आरक्षणाचा लाभ घेण्यासाठी पात्रता प्रमाणपत्र देण्यासाठी सक्षम प्राधिकारी म्हणून तहसिलदार यांना घोषित करण्यात येत आहे आणि आवश्यकता असल्यास जिल्हाधिकारी यांना एकाहून जास्त तहसिलदारांना सक्षम प्राधिकारी म्हणून घोषित करण्याचे अधिकार राहतील.
- (२) आर्थिकदृष्टया दुर्बल घटकासाठी आवश्यक पात्रता प्रमाणपत्र मिळण्यासाठी लाभधारकाकडून आवश्यक कागदपत्रांसह अर्ज प्राप्त झाल्याचा दिनांकापासून एका महिन्यात (३० दिवसांच्या आत) लाभधारकास पात्रता प्रमाणपत्र देणे बंधनकारक राहील. ते देण्यास नकार दिल्यास अथवा चुकीचे दिल्यास त्या विरुध्द अपिल दाखल करण्याची कार्यपध्दती खाली अपूमाणे विहिन्न करण्यात येत आहे.



In continuation to this office letter No.F.21-2/2015 (CU) dated 23.03.2016 (copy enclosed) regarding the policy of reservation in admissions and appointments, I am directed to inform you to implement the reservation policy in admissions and appointments as under :-

- University may follow the reservation policy in admissions in all courses as per (i) provisions contained in the Central Educational Institutions (Reservation in Admission) Act, 2006 (Gazette notification dated 04.01.2007) and as amended in 2012 (Gazette notification dated 20.06.2012). A copy of each of the CEI Act 2006 and Amendment Act, 2012 is enclosed for ready reference.
- For reservation policy in appointments of Non-Teaching staff, university may follow (ii) the quantum of reservation in Group 'C' and erstwhile Group 'D' posts as per instructions issued by DoPT Order No.36011/6/2010-Estt.(Res.) dated 25<sup>th</sup> June, 2010 (copy enclosed). For reservation in Group 'A' and Group 'B' posts, the reservation for SC is 15%, for ST is 7.5% and for OBC, reservation in direct recruitment is 27%.
- In teaching positions, reservation for SC is 15% and for ST is 7.5% at all three levels i.e. (iii) Professor, Associate Professor and Assistant Professor. However, 27% OBC reservation in teaching positions is applicable at the level of Assistant Professor only.

This is in reference to the discussion on Revised Budget Estimates for 2015-2016 held on 1<sup>st</sup> March, 2016 to 3<sup>rd</sup> March, 2016 in the UGC office. In this regard, I am directed to inform you that It has been observed that some of the Central Universities has not maintained the point wise reservation roaster. Therefore, it is to inform you to frame the point wise reservation roaster as per rules framed by the Govt. of India. Further, it is also to inform you that as per instructions of Govt. of India/UGC, the educational institutions receiving grant-in-aid from Central Government have to follow the prescribed percentage of Reservation i.e. 15% for SCs, 7½% for STs and 27% in OBCs in the matter of teaching and non-teaching posts as well as in admissions to various courses except Minority educational institutions under Article 30(1) of the Constitution. The Central Universities are receiving 100% grant from the Central Government/UGC and they have to follow the Reservation Policy of the Government of India for SCs/STs in toto i.e. 15% for SCs, 7½% for STs and 27% for OBCs in the matter of teaching and non-teaching posts as well as in admissions to various courses/degrees.

As per instructions of UGC, all the Central Universities have to maintain provide the reservation for SCs/STs in teaching positions at all levels i.e. Assistant Professor, Associate Professor and Professor and OBC reservation at Assistant Professor only.

The following Act of Parliament received the assent of the President on the 3rd January, 2007, and is hereby published for general information:—

## THE CENTRAL EDUCATIONAL INSTITUTIONS (RESERVATION IN ADMISSION) ACT, 2006

No. 5 of 2007

[3rd January, 2007.]

An Act to provide for the reservation in admission of the students belonging to the Scheduled Castes, the Scheduled Tribes and the Other Backward Classes of citizens, to certain Central Educational Institutions established, maintained or aided by the Central Government, and for matters connected therewith or incidental thereto.

BE it enacted by Parliament in the Fifty-seventh Year of the Republic of India as follows:—

1. This Act may be called the Central Educational Institutions (Reservation in Short title.

BE On to this Act, unless the context otherwise requires,

Definitions.

PUNE any bracehof study or faculty;

- (b) "annual permitted strength" means the number of seats, in a course or programme for teaching or instruction in each branch of study or faculty authorised by an appropriate authority for admission of students to a Central Educational Institution;
- (c) "appropriate authority" means the University Grants Commission, the Bar Council of India, the Medical Council of India, the All India Council for Technical Education or any other authority or body established by or under a Central Act for the determination, coordination or maintenance of the standards of higher education in any Central Educational Institution;
  - (d) "Central Educational Institution" means-
    - (i) a university established or incorporated by or under a Central Act;
    - (ii) an institution of national importance set up by an Act of Parliament;
  - (iii) an institution, declared as a deemed University under section 3 of the University Grants Commission Act, 1956, and maintained by or receiving 3 of 1956 aid from the Central Government;
  - (iv) an institution maintained by or receiving aid from the Central Government, whether directly or indirectly, and affiliated to an institution referred to in clause (i) or clause (ii), or a constituent unit of an institution referred to in clause (iii);
  - (v) an educational institution set up by the Central Government under the Societies Registration Act, 1860;

21 of 1860.

- (e) "faculty" means the faculty of a Central Educational Institution;
- (f) "Minority Educational Institution" means an institution established and administered by the minorities under clause (1) of article 30 of the Constitution and so declared by an Act of Parliament or by the Central Government or declared as a Minority Educational Institution under the National Commission for Minority Educational Institutions Act, 2004;

- (g) "Other Backward Classes" means the class or classes of citizens who are socially and educationally backward, and are so determined by the Central Government;
- (h) "Scheduled Castes" means the Scheduled Castes notified under article 341 of the Constitution;
- (i) "Scheduled Tribes" means the Scheduled Tribes notified under article 342 of the Constitution;
- (j) "teaching or instruction in any branch of study" means teaching or instruction in a branch of study leading to three principal levels of qualifications at bachelor (undergraduate) masters (postgraduate) and doctoral levels.

Reservation of seats im Central-Educational

- 3. The reservation of seats in admission and its extent in a Central Educational Institution shall be provided in the following manner, namely:
  - (i) out of the annual permitted strength in each branch of study or faculty, fifteen per cent. seats shall be reserved for the Scheduled Castes;





- (ii) out of the annual permitted strength in each branch of study or faculty, seven and one-half per cent, seats shall be reserved for the Scheduled Tribes;
- (iii) out of the annual permitted strength in each branch of study or faculty, twenty-seven per cent, seats shall be reserved for the Other Backward Classes.
- 4. The provisions of section 3 of this Act shall not apply to

Act not to apply in certain cases

- (a) a Central Educational Institution established in the tribal areas referred to in the Sixth Schedule to the Constitution:
- (b) the institutions of excellence, research institutions, institutions of national and strategic importance specified in the Schedule to this Act:

Provided that the Central Government may, as and when considered necessary, by notification in the Official Gazette, amend the Schedule;

- (c) a Minority Educational Institution as defined in this Act;
- (d) a course or programme at high levels of specialisation, including at the post-doctoral level, within any branch of study or faculty, which the Central Government may, in consultation with the appropriate authority, specify.
- 5. (1) Notwithstanding anything contained in clause (iii) of section 3 and in any other law for the time being in force, every Central Educational Institution shall, with the prior approval of the appropriate authority, increase the number of seats in a branch of study or faculty over and above its annual permitted strength so that the number of seats, excluding those reserved for the persons belonging to the Scheduled Castes, the Scheduled Tribes and the Other Backward Classes, is not less than the number of such seats available for the academic session immediately preceding the date of the coming into force of this Act.

- (2) Where, on a representation by any Central Educational Institution, the Central Government, in consultation with the appropriate authority, is satisfied that for reasons of financial, physical or academic limitations or in order to maintain the standards of education, the annual permitted strength in any branch of study or faculty of such institution cannot be increased for the academic session following ... the commencement of this Act, it may permit by notification in the Official Gazette, such institution to increase the annual permitted strength over a maximum period of three years beginning with the academic session following the commencement of this Act; and then, the extent of reservation for the Other Backward Classes as provided in clause (iii) of section 3 shall be limited for that academic session in such manner that the number of seats available to the Other Backward Classes for each academic session are commensurate with the increase in the permitted strength for each year.
- 6. The Central Educational Institutions shall take all necessary steps, which are required in giving effect to the provisions of sections 3, 4 and 5 of this Act, for the purposes of reservation of seats in admissions to its academic sessions commencing on and from the calendar year, 2007.

7. Every notification made under this Act shall be laid, as soon as may be after it is Laying of made, before each House of Parliament while it is in session, for a total period of thirty days which may be comprised in one session or in two or more successive sessions, and if, before the expiry of the session immediately following the session or the successive sessions aforesaid, both Houses agree-in-making any modification in the notification or both Houses agree that the notification should not be made, the notification shall thereafter have effect only in such modified form or be of no effect, as the ease may be; so, however, that any such modification or annulment shall be without prejudice to the validity of anything previously done under that notification.

## THE CENTRAL EDUCATIONAL INSTITUTIONS (RESERVATION IN ADMISSION) AMENDMENT ACT, 2012

No. 31 of 20121

[19th June, 2012]

An Act to amend the Central Educational Institutions (Reservation in Admission) Act, 2006

Bs it enacted by Parliament in the Sixty-third Year of the Republic of India as follows:-

1. This Act may be called the Central Educational Institutions (Reservation in Short title. Admission) Amendment Act, 2012.

2. In section 2 of the Central Educational Institutions (Reservation in Admission) Act, 2006 (hereinafter referred to as the principal Act), after clause (1), the following clauses shall be meerted, namely:-

- '(ia) "specified north-eastern region" means the area comprising of the States of Arunachal Pradesh, Manipur, Meghalaya, Mizoram, Nagaland, Sikklin, Tripura and the tribal areas of Assam referred to in the Sixth Schedule to the Constitution;
- (ib) "State seats", in relation to a Central Educational Institution, means such seats, if any, out of the annual permitted strength in each branch of study or faculty as

are earmarked to be filled from amongst the eligible students of the State in which such institution is virusted;

3. In section 5 of the principal Act, the following provisos shall be insected, namely:-

Provided that the State seats, if any, in a Central Educational Institution situated in the tribal areas referred to in the Sixth Schedule to the Constitution snall be governed by such reservation policy for the Scheduled Castes, the Scheduled Tribes and the Other Backward Classes, as may be specified, by notification in the Official Guzette, by the Government of the State where such institution is singulated.

Provided further that if there are no State seats in a Central Educational Institution and the seats reserved for the Scheduled Castes exceed the percentage specified under clause (i) or the seats reserved for the Scheduled Tribes exceed the percentage specified under clause (ii) or the seats reserved for the Scheduled Castes and the Scheduled Tribes taken together exceed the sum of percentages specified under clauses (i) and (ii), but such seats are—

- (a) less than fifty per cent, of the annual permitted strength on the date immediately preceding the date of commencement of this Act, the total percentage of the seats required to be reserved for the Other Backward Classes under clause (iii) shall be restricted to the extent such sum of percentages specified under clauses (i) and (ii) falls short of fifty per cent, of the annual permitted strength;
- (b) more than fifty per cent, of the annual permitted strength on the date immediately preceding the date of commencement of this Act, in that case no seat shall be reserved for the Other Backward Classes under clause (iii) but the extent of the reservation of seals for the Scheduled Castes and the Scheduled Tribes shall not be reduced in respect of Central Educational Institutions in the specified north-eastern region."

#### Agenda points discussed in the meeting:

The Controller of Examinations presented some issues that arose during the entrance examinations held on 27<sup>th</sup> June / 28<sup>th</sup> June 2021. The following issues were discussed in the Board of Examination and Evaluation.

#### 1. Missing Security Signs on the Answer Sheets:

The BEE discussed the issue related to missing security signs on the answer sheets that needed to sign by the candidates before sending answer sheets to the Supervisors. The BEE decided to include answer sheets in the final results list if the exam section of the Institute received unsigned answer sheets or answer sheets signed at other than designated places found more than 5% of the total received answer sheets.

#### 2. Missing seat numbers on Answer sheets:

The BEE decided to debar the candidates who sent answer sheets without seat numbers provided by the Institute well in advance for the entrance examinations 2021.

#### 3. Creation of Duplicate Exam link by the candidate:

The BEE discussed the issue that came to know before conducting the final entrance examination that someone created a Duplicate Exam link and sent it to his/her group members. After receiving complaints from some candidates about Duplicate Exam link that they received, a candidate accepted his mistake and explained to Dr Anurag Asawa (M.Sc. Entrance Group). Dr Anurag Asawa showed the message received from the candidate to members of the BEE, mentioning the regret and apology for the mistake.

The BEE approved his / her name for inclusion in the final entrance result list of the M.Sc. Entrance Exam 2021, without affecting his / her score in the entrance examination.

#### 4. Cheating Cases /Malpractices Issues:

The BEE discussed Cheating Cases/Malpractices that likely happened and did in the Entrance Exam. The BEE decided to take action against such candidates who indulged in the Entrance Exam after receiving reports from supervisors/IT Sections. The BEE decided to deduct 10 marks from the total obtained marks in the Entrance Exam if found any unfair means during Exams.

The Controller of Examination presented summary data on total applications received, and the actual candidates appeared for M.Sc./M.A./ B.Sc. Entrance Examinations 2021 as follows:

#### M.Sc. Programmes Entrance Result

Total 1579 candidates applied for Common Entrance Exam held on 28<sup>th</sup> June 2021 for Five M.Sc. programmes (Economics/Financial Economics/Agribusiness Economics/International Business Economics and Finance/Population Studies and Health Economics). Out of total candidates, 1476 candidates appeared for the Entrance Examination 2021. The result of Entrance examination 2021 of M.Sc. programmes for (batch 2021-2023) is prepared rank wise and preference-wise after considering all issues discussed earlier (points 1 to 4). The final result is presented in **Annexure-I.** 

The BEE discussed the entrance result of the M.Sc. programme 2021 and reviewed various issues and scenarios of entrance examination 2021 in comparison with the entrance exams conducted in previous years and the output of the same.

After discussing all issues, the BEE unanimously approved the M.Sc. Programme Entrance Examination Result 2021.

#### B.Sc. Programme Entrance Result

Total 473 candidates applied for this programme. Out of which 446 candidates appeared for the entrance examination. Also, 7 candidates applied under NRI/OCI/Foreign National category.

The result of entrance 2021 (For Indian nationals) is prepared rank wise for (batch 2021-2024) and presented in **Annexure-II**.

#### M.A. (Economics) Programme Entrance Result

Total 500 candidates applied for M.A. (Economics) programme. Out of which 428 candidates appeared for the Entrance Examination 2021. The result of Entrance Examination 2021 of M.A. (Economics) programme for (batch 2021-2023) is prepared rank wise and presented in (Annexure-III)

After discussing all issues, the BEE unanimously approved the M.A. Programme Entrance Examination Result 2021.

The BEE also discussed the issues related to the admission process and permitted to admit candidates as per the following terms and conditions.

- (i) The BEE resolved and permitted to admit up to 60 students in M.A. (Economics), and 60 students in each M.Sc. Programme, 150 students in B.Sc. (Economics) programme for academic year 2021-22, after considering the issues related to admission cancellations in the future due to COVID 19 situation.
- (ii) The BEE discussed issues related to tie marks or the same Rank issue to proper ranking of the candidates whose marks are tied. The BEE approved and permitted Admission Committees of various programmes to admit such candidates based on criteria such as the year of birth, then month and date, if a large number of candidates scored the same mark.

**Explanation:** Preference in admission is to be given to the students who are born earlier and elder among the competing candidates.

- (iii) The BEE discussed the tie marks issue. The members suggested that if few students get the same mark and it is unavoidable to resolve the issue, the Institute may consider the issue accordingly. In this case, BEE authorized to the Director, who will take the appropriate decision to increase the seats over and above 40 seats, if it is needed so.
- (iv) The BEE allowed applying Government of India Reservation policy to all M.Sc. Programmes / B.Sc. (Economics) with reservation percentage: 15 % for SC, 7.5 % for ST, and 27 % for OBC-non-creamy layer category, Supernumerally quota 10% for EWS, 4% for PWD (Persons with disabilities) and as per Government of India directions from time to time.
