The Board of Examination and Evaluation (BEE) considered and approved the results of Common Entrance Examination 2020 for B.Sc (Economics), M.A. (Economics), and M.Sc. programmes, the first two being approved earlier by an Interim Committee formed by the Officiating Director for the admission purposes. The details are as follows:

B.Sc. (Economics)

Total 470 candidates applied for this programme from all over India. Out of which 333 candidates appeared for the entrance examination. Also 15 candidates applied under NRI/OCI/Foreign National category. Out of which 9 candidates are admitted to the program. The result is prepared rank wise (For Indian Nationals).

The BEE approved the result of B.Sc. (Economics) that provisionally approved by the Internal Committee in its meeting held on 12/08/2020.

M.A. (Economics)

Total 467 candidates applied for M.A. (Economics) programme. Out of which 149 candidates appeared online and 02 offline for the Entrance Examination 2020. The result of Entrance examination 2020 of M.A. (Economics) programme for (2020-2022 batch) is prepared rank wise.

The BEE approved the result of M.A. (Economics) that provisionally approved by the Internal Committee in its meeting held on 17/08/2020.

The details of the result are given in the table and rank/merit list as (Annexure-I)

M.Sc. programmes

Total 1290 candidates applied for four M.Sc. programmes from all over India. Out of which 1063 candidates appeared online and 05 offline for the Entrance Examination 2020. The result of Entrance examination 2020 of all M.Sc. programmes for (2020-2022 batch) is prepared rank wise and preference-wise. The Institute also received three applications under foreign nationals category.

After the discussion and analysis of the results, the BEE unanimously approved the Entrance Exam Result 2020 of M.Sc. Programmes and three admission under foreign national category.

The details of the results are given in table and rank/merit list as (Annexure-II)

- (i) The BEE resolved that the Admission Committees of M.A. (Economics) and M.Sc. programmes are permitted to admit up to 60 students in M.A. (Economics), and 60 students in each M.Sc. Programme for 2020-21 academic year considering possibility of a large number of admission cancellation in future.
- (ii) The BEE considered the problem of the same marks that candidates scored in the entrance exam 2020. It is resolved that in case of tie-up of marks and rankings, the final ranking to be considered on the basis of the year of birth, then month and date, if a large number of candidates scored the same mark.

Explanation: Preference in the admission is to be given to the students who are born earlier and elder among the competing candidates.

(iii) The BEE discussed the tie up of marks issue. The members suggested that if few students get same mark, then the institute may consider the issue accordingly. In this case, the Director will take appropriate decision to increase seats over and above 40 seats, if it is needed so.

- (iv) The BEE allowed applying Government of India Reservation policy to all M.Sc. Programmes with reservation percentage: 15 % for SC, 7.5 % for ST, and 27 % for OBCnon-creamy layer category, Supernumerally quota 10% for EWS, 5% for Jammu and Kashmir and 3% Physically Handicapped quota.
- (v) The BEE allowed and approved applying the Govt. of Maharashtra Reservation Policy for M.A. (Economics) programme with percentage: 13 % for SC, 7 % for ST, and 19 % for OBC-non-creamy layer category, 3% for VJNT/DTN(A), 2.5% for NT(B), 3.5% for NT(C), 2% for NT (D), 12% for SEBC, 10% for EWS under General Category and 3% Physically Handicapped quota.
- (vi) The BEE approved the admission time duration of four days in each cycle. The next cycle will begin after four days as per iteration as below. The admission process will continue until all approved seats for four M.Sc. programmes and M.A. (Economics) are filled up.

Agenda points discussed in the meeting:

The Controller of Examinations presented some issues that arose during the entrance examinations held on 27th June / 28th June 2021. The following issues were discussed in the Board of Examination and Evaluation.

1. Missing Security Signs on the Answer Sheets:

The BEE discussed the issue related to missing security signs on the answer sheets that needed to sign by the candidates before sending answer sheets to the Supervisors. The BEE decided to include answer sheets in the final results list if the exam section of the Institute received unsigned answer sheets or answer sheets signed at other than designated places found more than 5% of the total received answer sheets.

2. Missing seat numbers on Answer sheets:

The BEE decided to debar the candidates who sent answer sheets without seat numbers provided by the Institute well in advance for the entrance examinations 2021.

3. Creation of Duplicate Exam link by the candidate:

The BEE discussed the issue that came to know before conducting the final entrance examination that someone created a Duplicate Exam link and sent it to his/her group members. After receiving complaints from some candidates about Duplicate Exam link that they received, a candidate accepted his mistake and explained to Dr Anurag Asawa (M.Sc. Entrance Group). Dr Anurag Asawa showed the message received from the candidate to members of the BEE, mentioning the regret and apology for the mistake.

The BEE approved his / her name for inclusion in the final entrance result list of the M.Sc. Entrance Exam 2021, without affecting his / her score in the entrance examination.

4. Cheating Cases /Malpractices Issues:

The BEE discussed Cheating Cases/Malpractices that likely happened and did in the Entrance Exam. The BEE decided to take action against such candidates who indulged in the Entrance Exam after receiving reports from supervisors/IT Sections. The BEE decided to deduct 10 marks from the total obtained marks in the Entrance Exam if found any unfair means during Exams.

The Controller of Examination presented summary data on total applications received, and the actual candidates appeared for M.Sc./M.A./ B.Sc. Entrance Examinations 2021 as follows:

M.Sc. Programmes Entrance Result

Total 1579 candidates applied for Common Entrance Exam held on 28th June 2021 for programmes (Economics/Financial Economics/Agribusiness Economics/International Business Economics and Finance/Population Studies and Health Economics). Out of total candidates, 1476 candidates appeared for the Entrance Examination 2021. The result of Entrance examination 2021 of M.Sc. programmes for (batch 2021-2023) is prepared rank wise and preference-wise after considering all issues discussed earlier (points 1 to 4). The final result is presented in Annexure-L.

The BEE discussed the entrance result of the M.Sc. programme 2021 and reviewed various issues and scenarios of entrance examination 2021 in comparison with the entrance exams conducted in previous years and the output of the same.

After discussing all issues, the BEE unanimously approved the M.Sc. Programme Entrance Examination Result 2021.

B.Sc. Programme Entrance Result

Total 473 candidates applied for this programme. Out of which 446 candidates appeared for the entrance examination. Also, 7 candidates applied under NRI/OCI/Foreign National category.

 - a. prepare a merit list of the successful candidates that are to be provisionally admitted and wait listed in the respective programme and disply at gipe website, subject to fulfillment of required qualifications, and submission of required documents in case of reserved categories, and under quota that claimed by the candidates,.
 - display only seat numbers of successful candidates, who are to be provisionally admitted and wait listed in each respetive programme on the gipe website.
- 3. The BEE unanimously approved a total programme-wise admission that are to be offered during the academic year 2022-23 as follows:
 - a. B.Sc. programme: The institute will admit provisionally total 155 students against 120 seats during the academic year 2022-23, keeping in mind the large number of admission cancellation and total 50 students be wait listed till the teaching for the programme starts. The Institute will offer admission to the students until 155 seats get filled up until teaching starts in academic year 2022-23. The Government of India reservation policy will be applied to this programme.
 - b. M.A. programme: The institute will admit provisionally total 80 students against 60 seats during the academic year 2022-23, keeping in mind the large number of admission cancellation and total 25 students be wait listed till the teaching for the programme starts. The Institute will offer admission to the students until 80 seats get filled up until teaching starts in academic year 2022-23. The members suggested that if few students get the same mark and it is unavoidable to resolve the issue, the Institute may consider such issue accordingly.

Therefore, the BEE unanimously authorized to the Vice Chacellor, who will take an appropriate decision to increase the seats over and above seats approved by the institute in pre-admission time, if it is needed so.

- 5. Government of India Reservation policy: The BEE allowed applying Government of India Reservation policy to all M.Sc. Programmes / B.Sc.  The BEE unanimously approved a <u>four days admission window</u> for each provisionally admitted candidate to complete and deposit their fees as per iteration schedules.

The seats will automatically go to the next wait listed candidates in the next admission cycle. The admission process will continue until all approved seats for five M.Sc. programmes, M.A. (Economics) and B.Sc. (Economics) are filled up.
