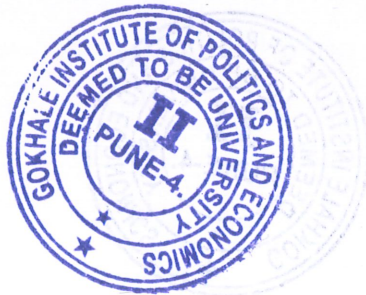
## GENERAL INSTRUCTIONS TO THE CANDIDATES
