JOB DESCRIPTION:

The Field Investigator will support field-based evidence generation for the research project by conducting surveys, interviews, facility observations, and documentation in assigned districts and states. The position requires a motivated individual with strong field communication skills, familiarity with mobile-based data collection, and the ability to follow research protocols accurately.

Key responsibilities:

- Conduct quantitative and qualitative field surveys in assigned districts/ states.
- Visit District Disability Rehabilitation Centres (DDRCs), Composite Regional Centres (CRCs), hospitals, educational institutions, government offices and other designated locations for data collection.
- Administer structured questionnaires using CAPI/mobile-based survey applications.
- Conduct interviews with beneficiaries, caregivers, officials, rehabilitation professionals and other stakeholders as per the research protocol.
- Carry out facility observations using standardised observation schedules.
- Obtain informed consent from respondents and maintain confidentiality and ethical standards throughout the study.
- Ensure completeness, accuracy and quality of data collected.
- Upload survey data on a daily basis following prescribed protocols.
- Report field progress regularly to the Research Associate/Project Coordinator.
- Travel extensively within the assigned state/district.
- Participate in training programmes, pilot surveys and review meetings.
- Maintain all field records, consent forms and documentation as prescribed.

ESSENTIAL QUALIFICATIONS:

Minimum Qualifications: Bachelor's Degree in Social Sciences, Social Work, Psychology, Public Health, Sociology, Economics, Special Education, Rehabilitation Studies or any equivalent discipline from a recognised university. Experience: Freshers may apply. Languages: Language Requirement (Essential) Applicants must be proficient in reading, writing, and speaking the local language of the state in which they will be deployed. Proof of language proficiency may be assessed during the selection process. Additionally, working knowledge of English for reporting purposes is desirable. States: Gujarat, Maharashtra, Odisha, Jharkhand, Kerala, Telangana, Madhya Pradesh, Uttar Pradesh, Jammu & Kashmir and Assam.

Desirable Qualifications/Experience:
